A resolution to amend the By-Laws of Orange Park
Lodge No. 267 F.& A.M. increasing Dues

Whereas, since 2009 and currently the By-Laws (4.01) of Orange Park Lodge require every member of the Lodge to pay dues of \$120.00 per annum.

Whereas, the Lodge has experienced continuing increases in Lodge insurance and other operating expenses. It is therefore prudent to increase dues to assure that the Lodge continues to maintain a sound financial position.

Whereas, the Lodge has voted to accept Credit Card payment from members for dues and other obligations resulting in a reduction in net income due to fees charged.

Therefore, be it resolved, that Orange Park Lodge By-Law (4.01) be amended to increase dues from \$120.00 to \$140.00 per annum:

4.01 Dues. - Every member of this Lodge shall pay to the Secretary, for the use of the Lodge, the sum of \$140.00 per annum, which shall include the Grand Lodge Per-Capita Assessment, which sum shall be due and payable in advance on or before the first day of each Masonic Year, which Masonic Year shall begin on the 28th day of December of each year and end on the 27th day of December of the following year, except life members, honorary members and those members whose dues are remitted in accordance with Masonic Law.
